TWO ISSUES ARE ON THE BALLOT FOR CONSIDERATION

- The Reauthorization of Local Sales and Use Tax in Pecos at the Rate of Three-Eighths (.375%) of One Percent to Continue Providing Revenue for Maintenance and Repair of Municipal Streets. The Tax Expires on the Fourth Anniversary of the Date of this Election Unless The Imposition of the Tax is Reauthorized
- Imposition of an Ad Valorem Tax in the Amount of Five (5) Cents for each \$100 Valuation of the Property for Maintenance of City Cemeteries

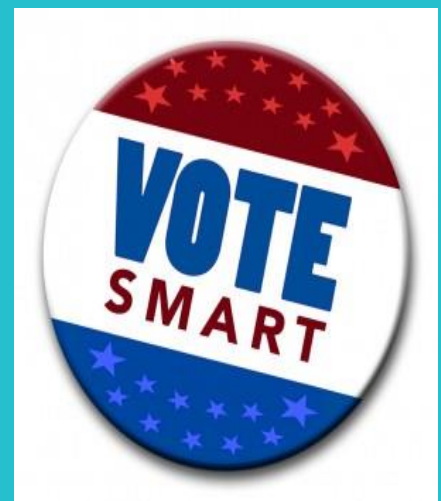
